Short Learning Programme (SLP) Outline: Law Enforcement by Peace Officers (LEPO) 40 contact hours (5 days)

Purpose of Short Learning Programme (SLP

This credit bearing SLP will prepare students to enforce municipal by-laws and legislation. It is aimed at the training of any official who is responsible for the implementation and enforcement of by-laws or legislation and for whom appointment as a peace officer in terms of Section 334 of the Criminal Procedure Act is required.

Range Statement

This SLP will provide the student with an opportunity to acquire the competencies relevant to the regulatory framework for law enforcement officials and will provide the overarching understanding of legislation to conduct law enforcement

Minimum Entrance Requirements/Learning to be in place for this Short Learning Programme

Access to this short learning programme is granted to applicants who meet the following minimum entrance requirements:

- A National Senior Certificate (NSC) granting access to a Higher Certificate or
- A National Certificate (Vocational) Level 4 (NCV4) or
- An appropriate Further Education and Training Certificate or equivalent.

Learning to be in Place:

• It is assumed that the student would be competent in the language of instruction (English at NQF Level 4), Mathematical Literacy (NQF Level 4) and the theoretical knowledge and understanding accomplished at that level.

Assessment Practice

Assessment of students consists of a written knowledge test and a written practical assessment, which requires the completion of applicable documentation and notices in terms of a given scenario.

The knowledge test represents 40% of the total marks, while the practical assessment makes up the remaining 60%. Students must obtain 42 out of 60 marks for the practical part (a 70% pass-rate requirement). In order to comply with the requirements of the course, both the theory and practical components of the assessment need to be met. A pass mark of 50% overall is required.
